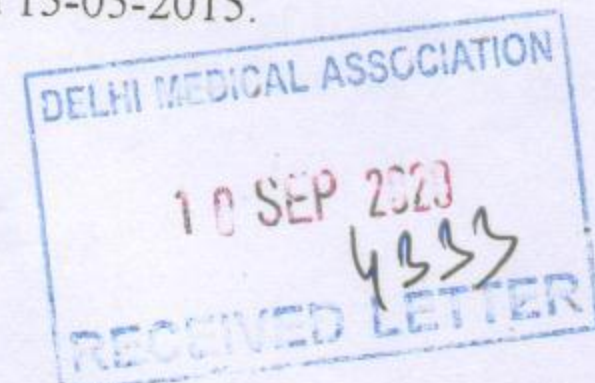

Category	Maximum Charges
a. Poly clinics/ Dispensaries (Health Facility other than Delhi Govt.)	Rs. 891/- per month
b. Forensic Labs	Rs. 891/- per month
c. Bedded facility 1-7 (Health Facility other than Delhi Govt.)	Rs. 891/- per month up to 7 beds
d. 8 beds and above (Health Facility other than Delhi Govt.)	Rs. 119/- per bed per month

- Entire Bio Medical Waste for Delhi Govt. Health Care Facilities continues to be collected, transported, treated and dispose off free of cost as per the DPCC Order No.DPCC/WMC-I/CBWTF/2013/569-1076 dated 15-05-2015.
