Subject: Proposal for DMA 2nd Floor Rent

Dear Sir,

We have been informed that Delhi Medical Association desires to rent out its roof top with a temporary structure hall which includes a kitchen, 2 bathrooms, one room and the open space for the usage of banquet, restaurant and convection centre or any other appropriate use.

We have been informed that Rs. 1,00,000,00 (Rupees One Crore) is required to be deposited as advance rent out of which Rs. 1,00,000/- (Rupees One Lakh) every month shall be deducted as an advance rent.

We have also been informed that Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand) + GST has to be deposited as rent every month in advance by 7th Day of the month.

We have shown it to our client who is willing to be a tenant for the 2nd floor as per the following and client has agreed for the same.

We accept the financial liabilities as rent of Rupees One Crore advance and Rs. 1.5 lakh per month provided:

1. To use the premises for the purpose of banquet, restaurant/ convection centre it is mandatory for the building to have a fire NOC. The landlord i.e. the Delhi Medical Association shall get the fire NOC for the total building.
2. An uninterrupted electricity supply has to be provided for the 2nd floor. The electricity shall be charged on the basis of actuals by a separate sub-meter.
3. There will be a water supply for at least 10,000 liters exclusively for the 2nd floor and the space for setting of RO Plant near the water tanks shall also be arranged.
4. A separate lift shall be installed and a separate staircase and entry shall be available for the uninterrupted usage of 2nd floor. The usage of other stair shall be available 24X7 as a fire exit and also when there is banqueting process going on Ground and 1st floors. The usage of other lift shall be uses the 2nd lift, he shall pay Rs. 2500/- per day.
5. The area of the roof which is lying vacant shall be allowed to be converted into covered area. The cost of covering the area and decorating it as per the purpose shall be borne by the tenant and shall be the property of DMA after expiry of the tenure.

The tenure of the tenancy shall be 9 years with the rent escalating by 15% every three years.

After the completion of tenure seeing the investment in business, the first right of refusal for renewing the lease shall remain with the tenant with the escalation of 20% of the rent.

The DMA Shall be eligible for the 12 usages in a year if the banquet space for lunch or dinner as a part of the agreement and more if desired shall have to pay the rent charged by the tenant with the discount of 25%.

The Tenant shall also be allowed to book the other parts of Delhi Medical Association building if available for the rent with the discount of 25% at the prevailing and decided rates.

The tenant shall be responsible for upkeep of the top floor in best of its form.

The banqueting and tenting rights of DMA convection hall shall be exclusively remained with the tenant.

He will provide a continuous kitchen and cafeteria for DMA office.

He tenant shall provide DMA functions banqueting at a pre-fixed and pre-decided rates with only 5% market escalation every year.

Kindly note that 3 months' rent shall be our commission for the convenient conduction of the deal. If you agree kindly inform me and issue an acceptance letter for me to enable me to pursue the matter further for further negotiation.



MINUTES OF EXTRA ORDINARY GENERAL BODY MEETING HELD ON 19th AUGUST 2025

A meeting of the Extraordinary General Body Meeting (EGBM) of Delhi Medical Association was held on 19th August 2025 at 2.30 at DMA House, Daryaganj, New Delhi.

The meeting was adjourned for 30 minutes due to lack of quorum and was then reconvened at 3.00 pm. As President Dr. Girish Tyagi was not present in the meeting. The meeting was chaired by DMA Vice President Prashant Seth and proceedings were conducted by Hony. State Secretary Dr Satish Lamba

Agenda of the meeting was taken up as follows:

Agenda1:To receive and confirm the minutes of Annual General Body Meeting held on 31st March, 2025

The minutes were read out by the Hony. Secretary and confirmed by members attending the EGBM.

Agenda 2: To adopt the audited accounts for the preceding financial year i. e. wef 01/04/2024 to 31/3/2025.

Hony. Secretary Dr. Satish Lamba said that the accounts were audited by DMA approved auditors and vetted by the Finance Committee of DMA and also circulated to the members, these were accepted in toto.

Agenda3:To appoint Auditors for 2025-2026

It was pointed out that continuity of auditors assures safety and integrity of accounting practices. Therefore, it was decided to continue with the same Auditor for FY 2025-2026..

Agenda4: To appoint an Hony. Legal Advisor for the year 2025-2026.

Mr. Rupesh Dutta was appointed as Hony. Legal Advisor for the year 2025-2026.

Agenda5: To sanction the budget for the ensuing Financial Year 2025-2026.

The budget was presented and accepted unanimously by all members. The President / Hony. Secretary / Fin Secretary were authorized to allocate funds as per evolving needs in accordance with established practices.

Agenda6: Any other matter.

Dr. Arvind Chopra raised the issue of the newly constructed second floor. He said that about Rs. 1.8 crores were spent on its development as a new source of income, but due to legal complications like sealing of the premises and it being declared unauthorized, the floor has not been utilized. As a result, the money and efforts spent have gone waste.

Dr. Prem Aggarwal informed that, through an agent, (Wealth & Property consultants Mr. RPS Bawa dated 2nd November 2024) he had submitted a proposal to rent out the second floor for use as a banquet/convention hall. This proposal was approved in principle at the State Executive meeting held on 7th November 2024. As per the Executive Committee's instructions, the proposal was circulated to all members to see if any better offers could be received.

Since no better proposal came and no objections were raised, Dr. Aggarwal said it should now be acted upon. He also mentioned that in his proposal, the premises would be rented on an "as is, where is" basis, with the condition that alternate electricity supply, fire safety equipment, and an additional fire exit would be arranged.

Dr. Aggarwal further offered that if the office accepts the proposal, he is ready to pay Rs. 20 lakhs in advance at the time of signing the agreement, to establish a generator set, install fire safety equipment, and create the additional fire exit.

Dr. Satish Lamba said that the expenses for creating extra space for the fire exit should be borne by the tenant. Dr. Ramesh Datta, Dr. Anil Sharma, Dr. Ashwini Dalviya, and others supported the proposal and recommended that it should be executed soon.

Following this, Dr. Aggarwal submitted a cheque of Rs. 10 lakhs as advance payment towards acceptance of the proposal.

The house approved the proposal, accepted the advance, and authorized the President in Chair, Dr. Prashant Seth, along with Dr. Satish Lamba, Dr. Sunil Satrawal, and Dr. Ashwini Dalviya, to negotiate the terms and conditions.

The house also expressed the desire that the agreement should be executed as soon as possible, preferably before Diwali, so that the association can start earning regular income and repay its loan on time.

The meeting ended with a Vote of Thanks to the chair.
